Subject : Filling up of one post of Economist in the Directorate of Economics and Statistics, Department of Agriculture & Cooperation on deputation basis.

Sir,

It is proposed to fill up one post of Economist in the pay scale of Rs. 14300-400-18,300/- (General Central Service, Group 'A', Gazetted, Non-Ministerial) in the Directorate of Economics and Statistics, an attached Office under the Department of Agriculture & Cooperation, on deputation (including short-term contract) The Headquarters of the post are at New Delhi, but can be changed to a place anywhere in India. The following are eligible for appointment to the post of Economist on deputation basis:

Officers of the Central Government/State Government/Universities/
Recognised Research Institutions/Autonomous Organisations:

- (a) (i) Holding analogous posts on regular basis; or
(ii) with 5 years regular service in posts in the scale of Rs.12000-16500 or equivalent; or
(iii) with 10 years regular service in posts in the scale of Rs.10000-15200 or equivalent; and
- (b) possessing the following Educational Qualifications and experience:
 - v) Doctorate in Economics, Agricultural Economics or Statistics from a recognized University/Institution or equivalent;
 - vi) 10 years experience in a supervisory capacity of research investigation in Economics or Economics Statistics in a Government Department or commercial concern of repute or of conducting and guiding research in these fields in any University or/Institutions or training and Research as evidenced by published works.

2. As per the Recruitment Rules for the post, period of deputation to the post shall ordinarily, not exceed 4 years. The vacancy is, however, a lien vacancy and its regular incumbent is not expected to revert thereto before completion of his deputation for 3 years on 27.12.2005. Therefore, the post is proposed to be filled up

on deputation basis (including Short-Term Contract), on the recommendation of UPSC by appointment of an officer up to 27.12.2005 or until further orders, whichever is earlier.

3. Period of deputation, including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department, shall ordinarily not exceed three years. The maximum age-limit for appointment on deputation is 56 years as on the closing date of receipt of applications. The candidates who apply for the post will not be allowed to withdraw their candidature subsequently.

4. The officer selected will have the option to draw his grade pay in his parent post plus deputation (duty) allowance in accordance with the Ministry of Finance's Order No. F 14(2)/IC/86 dated 13.3.87 and other orders issued in this regard by the Ministry of Finance from time to time or to have his pay fixed in the scale of pay of the post subject to certain restrictions in this regard.

5. Applications, in duplicate, in the enclosed proforma (**Annexure-I**) of the eligible officers who could be spared in the event of their selection – along with the attested copies (with attestation done by an officer not less than the rank of Under Secretary to the Government of India) complete and up-to-date CR Dossiers for the last 5 years, Integrity Certificate and a certificate indicating the details of minor/major penalty imposed during the last 10 years – may be sent to the **Under Secretary (EA), Department of Agriculture & Cooperation, Room No. 537, Krishi Bhawan, New Delhi**, within 45 days of publication of advertisement in respect of this vacancy in the Employment News, which is being issued separately. While sending the applications, it may be verified and certified that the particulars furnished by the Officers are correct and that no disciplinary case is pending or contemplated against the Officers. Applications not in the prescribed proforma or those received after the last date or not received through proper channel or not accompanied by the complete and up-to-date Confidential Report Dossiers shall be liable to be rejected.
