Applications are invited for filling up the post of Registrar, Railway Claims Tribunal, Delhi Bench in the pay scale of Rs.18400-22400/- by transfer on deputation basis of: -

(a) Officers of Central/State Governments/High Courts:

- (i) holding analogous posts on a regular basis; or
- (ii) with 5 years regular service in posts in the scale of Rs.14300-18300/- or equivalent; and

(b)

- (i) having a degree in Law from a recognized University or equivalent; and
- (ii) 10 years experience in Court procedures, Commercial/.Railway Claims matters including administrative experience at Group 'A' level.

NOTE: Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not exceed 3 years. The maximum age limit for appointment by transfer on deputation/transfer shall be not be exceeding 56 years as on the closing date of receipt of applications.

2. Application from the candidate duly signed by him in the proforma, as indicated in the Annexure-I, duly completed, should reach within 60 days from the date of issue of this letter. The applications may be addressed to Deputy Secretary (D), Ministry of Railways (Railway Board), Room No.110-A, Rail Bhavan, New Delhi alongwith the certificate given under Annexure-1 from the authority forwarding the application. The CR Dossiers of officers recommended may also please be sent.

3. It is requested that the requirement may please be circulated among all the eligible officers of Ministries/Departments concerned and nominations of willing officers may please be forwarded to this Ministry urgently.

4. Applications received after the closing date of receipt of applications or without CR dossiers or otherwise found incomplete are liable to be rejected. Wherever gradings have been indicated in ACRs by denoting A+, B+, etc the equivalent gradation viz. Outstanding, Very Good, Good, etc may also be indicated for proper appreciation.

Officers who apply for the post will not be allowed to withdraw their candidature subsequently.
