SLOVAK GOVERNMENT SCHOLARSHIP 2004-2005

Applications are invited, on paper in the format at Annexure, from Indian nationals residing in India, for the award of 2 Scholarships offered by the Government of Slovak Republic. For Master degree level studies in Economy Management & Agriculture.

Qualification:- First Class Bachelor Degree with minimum of 60% marks in the relevant subject.

Age limit:- Below 26 years as on 30-04-2004.

Applications of overage and/or overqualified candidates in the same subject shall be summarily rejected without any correspondence.

Salient features of the Scholarships are as under:

- Scholarship holders will receive during the period of study, a monthly scholarship of 5000 SKK for PG studies.
- The scholarship is non-transferable.
- Studies will be imparted in Slovak Language
- Scholarship holders are exempted from paying administrative fees for submission of the application for granting and extending of the long-term stay permit in Slovak Republic.
- The period of study includes one year of the language and professional preparation for applicants from the developing countries.
- Accommodation in students dormitory and board in students cafeterias under the same conditions will be provided as provided to Slovak students.
- Travel cost from India to Slovak Republic and back is to be borne by the candidate or his/her Employer/Sponsor.
- The health care shall be provided as it is provided to the employees of the respective university.

DURATION: As per rules of Slovak Universities.

INTERVIEW/EXAMINATION : The Slovakian Universities generally do the selection on the basis of application accompanied by the necessary documents. However, if the Universities are not satisfied with the documents, then they have the right to call the applicant for an interview or examination, before admission to the study course after he/she reaches Slovak Republic.

NOTE:

(A) Attested copies of following documents must be attached with the application:

1. Proof of Age, 2. Educational Qualification Degree's/Certificate/Diploma's etc 3. Experience Certificate from the Employer, 4.University/College Mark sheets, 5.No Objection certificate from the employer, if employed 6.Proposal for study/research/academic justification and (7) Passport.

(B) A recent passport size photograph of candidate to be affixed on the prescribed application form

(C) The requisite documents should be attested by a Gazetted Officer.

(D) Candidates who have been already abroad for study/specialization/training for a period exceeding six months either on scholarship or on their own are eligible to apply only if they have been in India for at least two consecutive years after their return from abroad as on 30-04-2004.

(E) Applications of candidates who are as present residing abroad will not be considered.

(F) Candidates should have sufficiently good knowledge of India and the donor country.

(G) Applications in the subjects not relevant and those applications submitted not in the prescribed format & without the required documents shall be treated as incomplete and shall also be summarily rejected without any correspondence.

(H) No correspondence will be entertained with candidates if not selected for interview/scholarship.

(I) Canvassing in any form will be a disqualification.

(J) Employed candidates must send their applications through their employer's along-with no objection certificate. Advance applications can be submitted, with the understanding that the application through proper channel should reach before the interview.

(K) Applications received after the prescribed last date will not be entertained.

(L) The decision of the Selection Committee with regards to selection or otherwise of the candidate will be final.

(M) Candidates must satisfy themselves about the offer of the scholarship before applying. Once an application is received it will be presumed that the candidate is satisfied and no queries/representations will be entertained thereafter.
