Bidders have to submit sealed quotations in the enclosed proforma at KERAFED Head Office, Thiruvananthapuram on or before 08/03/2023 (Wednesday) 11.00 AM. Date of opening the tenders is on 08/03/2023 at 2.00 PM. KERAFED reserves the right to reject / partially accept (Unit quotes) the bids.

INSTRUCTIONS AND CONDITIONS TO TENDERS:

- 1. The tender should be submitted in sealed cover super-scribed as "TENDER FOR THE SALE OF SCRAP MATERIALS"
- 2. The rates and amount against each item shall be filled up only in the tender form issued to the tenders.
- 3. The tenders shall be accompanied by the **EMD** of **Rs. 1,00,000/- (Rupees One Lakh only)** shall be submitted by DD issued by any nationalized bank/ co operative bank/ scheduled bank in **favour of Managing Director, KERAFED** payable at Trivandrum.
- 4. In case Tender Document is downloaded from the web site, the cost of Tender Document i.e Rs. 2,500/- (Rupees Two thousand and five hundred Only) +18% GST should be enclosed with the Tender by way of Demand Draft in favour of The Managing Director, KERAFED payable at Trivandrum.
- 5. The offer price shall be quoted for the scrap **per kg** basis "AS IS WHERE IS BASIS" plus GST.
- 6. Period of tender submission 27.02.2023 to 08.03.2023 between office hours.
- 7. Last date of receipt of completed tender form on 08.03.2023 up to 11.00 AM.
- 8. The tenders will be opened on **08.03.2023 at 02.00 PM**. at KERAFED HO, Vellayambalam, Thiruvananthapuram with the presence of available tenderers.
- 09. The Tenderers are free to inspect the Scrap at the locations listed above on any working day with effect from 27.02.2023 to 07.03.2023 in the presence of KERAFED Officials.
- 10. EMD amount shall be paid through Demand Draft in favour of Managing Director, KERAFED payable at Trivandrum. The tender not accompanied with the full value of prescribed EMD and in the format prescribed will be summarily rejected. Late tenders will not be accepted. EMD does not bear any interest and will be returned to unsuccessful Bidder.
- 11. The tender shall be awarded based on the **highest offer** received for materials. Up on award of the contract, the particular highest bidder shall deposit an amount equivalent to the actual value of the approximated quantity of scrap items.
- 12. Tender may be quoted for full items listed above. Parties called for negotiation in the case of quoting same rate for materials.
- 13. The bidder shall clear the material out of the premises at its own arrangements/ cost, etc.
- 14. All the intending bidders may inspect the scrap put up for disposal during the working hours of the organizations. In any case it will be presumed that they have inspected and verified themselves about the material before quoting.

- 15. The tender will be rejected if the rate is not above the MRP as decided by the competent Govt. authority.
- 16. KERAFED reserves the right to reject / partly accept, any or all offers without assigning any reasons whatsoever.
- 17. If any party emerges as higher bidder for any items (s) and if the party does not lift any of the material within stipulated time, then WHOLE EMD OF THE PARTY SHALL BE FOREFITED.
- 18. The sale of items shall be on the basis of the highest rates quoted for each item subject to other conditions. Based on the highest offer for listed items.
- 19. The highest bidder is required to deposit the estimated total value within 20 working days from the date of awarding the order, failing which the entire EMD of such bidder shall be forfeited and KERAFED shall be free to offer it to the next bidder or to cancel the tender for the materials.
- 20. The material shall be lifted on the basis of actual measurement / weight taken at our weigh bridge in the presence of the representative of KERAFED after paying full value of the materials.
- 21. The bidder has to settle all the payments before issuing Gate Pass.
- 22. Taxes @ % direct or indirect (if any) will be charged from the bidder extra as per prevailing rate on MRP of the scrap material.
- 23. The tender shall be liable for rejection if any one of the above said requirement are not complied with.

TENDERER'S NAME & SIGNATURE WITH DATE

PROCEDURE FOR DISPOSAL OF SCRAP:

a) The successful Tenderer shall deposit the total lump sum amount in Rupees for individual category of scrap as detailed under by way of Demand Draft in favour of The Managing Director, KERAFED payable at Trivandrum towards the cost of Scrap (approx) within 20 working days from the date of awarding the order. The details of lump sum amount to be paid for individual category of scrap shall be calculated as per the formula as under:

Amount in Rupees for the lump sum payment = Total Approx. quantity indicated Multiply by the offer price quoted by the party in the tender.

- b) It may be noted that the quantity mentioned in above against individual category of scrap shall be considered as approximate quantity, but the actual payment would be calculated on the basis of actual quantity of scrap to be lifted. In case the actual quantity is less than the quantity mentioned above Column, the balance amount will be refunded. If the actual quantity is more than the quantity mentioned in the above Column, the tenderer have to pay the remaining amount.
- c) The truck/tempo for Scrap lifting and carrying shall be arranged by tenderer at their own cost. The tenderer shall have to make arrangement for loading of scrap to truck/tempo at their own cost and KERAFED will not pay any charges for the same.
- d) Prior to the loading of scrap on the Truck/Tempo, the empty Truck/Tempo shall be taken to the Weighing Bridge for weighing in presence of official from KERAFED.
- e) The loaded truck would again be sent to the weighing scale for weighing, and the weight of material would be calculated for payment of quantity of scrap based on the quoted price.
- f) Rate quoted will be valid up to 60 days from the date of awarding the order. The Tenderer (H1) should lift up all the listed material within the time limit.
- g) All responsibility related to labour P.F., ESI, Insurance etc. or any taxes as applicable will be of the successful Tenderers. KERAFED shall not be responsible for the same.
- h) Tenderer (H1) is liable for any accidents, injuries and material damage during the lifting up of scraps.
- i) Tenderer (H1) have to sign an agreement executed by kerafed for the "sale of scrap" in Kerala Govt. Stamp paper worth Rs.200/-
