Applications are invited from eligible candidates for selection to the post of Public Prosecutor in Vigilance and Anti- Corruption Bureau on contract basis for a period of 1 year or till a regular PSC hand joins duty, whichever is earlier. The applications in the prescribed proforma (in Annexure-1) may be forwarded (by post) to the "Additional Chief Secretary, Vigilance (C) Department, Main Block, Government Secretariat, Thiruvananthapuram- 695001" within 30 days from the date of publication of this



notification in the official gazette. The envelope containing the application should be superscribed as "APPLICATION FOR THE POST OF PUBLIC PROSECUTOR IN THE VIGILANCE & ANTI- CORRUPTION BUREAU ON CONTRACT BASIS". The details are as follows:

1	Public Prosecutor	9	Rs.75,000/-	No person shall be eligible for appointment by direct recruitment under these rules, if the person has completed 45 years of age on the 1st day of January of the year in which applications for appointment are invited. Note : Usual relaxation in upper age limit shall be allowed to candidates belonging to Scheduled Castes/ Scheduled Tribes and Other Backward Classes.	(1) Graduation in Law from a UGC recognized University or a National Institute established by the Government of India or Institute established by the Government of Kerala. (2) Ten years of active practice at the Bar OR Eight years of service as Assistant Public Prosecutor in either grade or both grades together, on the date on which applications are invited.

NOTE

1. Applications received after the due date as well as any incomplete applications will be summarily rejected.
2. Candidates should have a valid email ID.



3. Those candidates whose applications are found to be in order will be called for an interview. The place and date of the interview will be intimated in due course. The candidates who are shortlisted for interview will be intimated individually.
4. The selected candidates will be posted in any of the seven courts of the Enquiry Commissioner and Special Judge and in any of the two courts of the Vigilance Tribunal in the State.
5. Government reserves the right to reject any or all the applications received without assigning any reason thereto.
